## 2017 LOSAP Contribution

Per an email we received from Donna Armitstead of Penflex, Inc.:

The State made some changes to the service award program for 2017, the States contribution will be double the municipality's contribution, up to a maximum State contribution of \$390. Therefore, a municipality must only contribute \$195 per participant in order to receive the maximum State contribution of \$390.

per volunteer, but the volunteer receives only \$585, a reduction of \$103.22 from last year. Therefore, we \$688.22 total.
