INSURANCE REQUIREMENTS: Application shall be accompanied by a certificate of insurance identifying the Village of New Glarus as a party insured in the amount of \$500,000 for damage to property and \$500,000 for injury to one person and \$1,000,000 for injury to more than one person caused by the blasting.

NOTIFICATION: The permittee, at his/her expense, shall place one (1) publication in the official newspaper of the Village of New Glarus identifying the location and time period of each blast prior to the blasting period.

BLASTING LOG: Original copy of blasting log shall be filed with the Clerk/Treasurer within 48 hours after the blast, and a copy kept at the quarry office.
