**BOND:**

I \_\_\_\_\_, hereby indemnify and save harmless the Village of New Glarus and its officers from all liability for accidents and damage caused by any of the work covered by this permit, and I will fill up and place in good and safe condition all excavations and openings made in the street, and will replace and restore the pavement over any opening I may make as near as can be to the state and condition in which I found it, and keep and maintain the same in such condition, normal wear and tear excepted, to the satisfaction of the Village Board for a period of one (1) year, and that I will pay all fines of forfeiture imposed upon me for any violation of any rule, regulation or ordinance governing street openings or drainlaying adopted by the Village Board and will repair any damage done to existing improvements during the progress of the excavation in accordance with the ordinances, rules and regulations of the Village. If the Village shall elect to make the street repair, the person opening the street will pay all costs of making such repair and of maintaining the same for one (1) year.
