

CHECKLIST FOR ZONING CHANGE APPLICATION

Completed zoning change application must be submitted to Village Clerk's Office, along with fee and other requirements outlined by checklist. ***Applications must be received one week prior to the Plan Commission meeting in order to be placed on agenda.*** The Plan Commission meets the 3rd Thursday of each month and Village Board meets the 1st and 3rd Tuesday.

The application will be placed on agenda only after completed form and fee have been filed with the Village Clerk's Office. Please note all applications must be reviewed by the Plan Commission and forwarded to Village Board for a public hearing and final action.

Required Items:

- ___ 1. Completed zoning change application.

- ___ 2. Plot Map drawn to a scale of one (1) inch equals one hundred (100) feet showing the area proposed to be rezoned, its location, its dimensions, the location and classification of adjacent zoning districts and the location and existing use of all properties within three hundred (300) feet of the area proposed to be rezoned.

- ___ 3. List of names and addresses of owners of property within 100 feet of premises.

- ___ 4. Fee of \$150.00 (Resolution R10-05).
