Payments are accepted:

- At the Green County Treasurer's Office. Hours are Monday through Friday from 8 a.m. to 4:30 p.m. The offices will be closed December 25-December 26, 2023 and January 1, 2024. An after-hours drop box is located on the east door of the Green County Courthouse.
- At the following banks: Lake Ridge branches in New Glarus, Belleville and Brooklyn; The Bank of New Glarus branches in New Glarus, Brodhead, Belleville, Monroe and Juda; and Woodford State Bank branches in New Glarus, Argyle, Blanchardville, Monroe and South Wayne. Please check directly with the bank for business hours.
- By credit/debit card or e-check at www.greencountywi.org using the quick link "Pay Taxes Online". A fee of 2.35% is charged for debit and credit card payments. A fee of \$1.50 is charged for e-checks. Receipts will be returned by mail only if a stamped self-addressed envelope is included with your payment.
- Payments cannot be dropped at the Village Clerk's Office/Utility Payment drop box.

FIRST DOLLAR CREDIT

The First Dollar Credit is a property tax credit on real estate parcels containing improvements and is calculated using the Equalized Value School Tax Rate and has a Maximum Credit Value, similar to the Lottery Credit. Taxpayers may receive more than one First Dollar Credit. The credit is divided equally between the two installments. If you do not see the Credit reflected on your tax bill and believe you are eligible, please contact either the Village or County Treasurer's Office.

LOTTERY CREDIT

Taxpayers should double-check their tax bill for the Lottery Credit. To qualify: You must own a home in Wisconsin AND occupy that home as your *primary residence on January 1* of the year in which the tax is levied. If the credit was not applied and you feel you are entitled, please contact either the Village or County Treasurer's Office. More information on these credits can be found at www.revenue.wi.gov and type the name of the credit in the search engine.

NOTICE TO DOG AND CHICKEN OWNERS:

Dog and chicken owners in the Village of New Glarus should purchase their 2024 dog and/or chicken license from the Village Clerk. **The fees are increasing in 2024** and are as follows: \$15.00 for altered dogs, \$29.00 for dogs not altered. A new chicken license is \$40; a renewal is \$20. To obtain a dog license you must provide the following: PROOF OF RABIES VACCINATION FROM VETERINARIAN; VETERINARIAN PROOF OF SPAYING OR NEUTERING; LICENSE FEE. To obtain a chicken license,

please contact the Village Clerk's office at 608-527-2510. Owners that do not license their dogs and chickens are subject to possible fines.

2024 VILLAGE BUDGET

Similar to other communities, the General Fund, which includes most of the Village's operations, is largely dependent on property taxes. Of the Village's overall tax levy, the General Fund is approximately 42%. This budget works to maintain the level of service expected by our residents, includes the use of surplus funds, and captures additional tax revenue from new construction.

DESCRIPTION OF FUNDS:

General Fund: General Government (Elections), Public Safety (Police, EMS, Fire), Public Works, Parks &

Recreation, Conservation and Development

Debt Service: All General Obligation Debt Payments

Employee Payout: Fund held to cover benefit pay-outs on employee termination

Library: Library operations

Chalet: Operations for the Chalet of the Golden Fleece Museum

Capital Projects: Capital Expenses (street projects, vehicle & equipment purchases)


Solid Waste: Garbage Pick-up and Disposal Charges

WHERE DO YOUR PROPERTY TAXES GO?

There are four taxing jurisdictions that make up the total of your tax bill. The Village Treasurer's Office receives the annual levy amount from the taxing jurisdictions, calculates the tax bill, and distributes the taxes collected to each of the jurisdictions. In 2023, the distribution of taxes collected included: New Glarus Schools (44%), Village of New Glarus (33%), Green County (20%) and MATC (3%).
