By Unanimous Consent, Chair Kruse moved item 7a up on the agenda: Referral from Plan Commission: Consideration/Discussion: Safety Evaluation of proposed Driveway locations for proposed 4k-2nd Grade Primary School: The Committee asked Village Engineer Patrick Rank some general questions related to the site plan including other access points considered, lighting, and impact on the neighborhood. Rank encouraged the District to file an official site plan application to fully consider the site plan as a whole. No action was taken.
- 5. <u>Public Hearing: Special Assessments for 9th Avenue between 2nd Street and 8th Street: Chair Kruse opened the public hearing at 6:50 PM.</u>
 - Brad Beal stated he paid to install the curb and gutter when it was first put in the 1970s and does not believe he should be assessed for the replacement. He also does not believe it is fair that neighbors who did not install the curb and gutter will now not be assessed for their installation. Beal stated he would prefer the Village stop issuing special assessments and spread the entire cost across the Village tax roll. Administrator Daily indicated the Village could choose to end their policy of special assessment but that would require action by the Village Board to do so and to date the Village Board has decided to continue issuing special assessments.
 - Beth Luchsinger asked if the Village will inform the resident if their lateral needs to be replaced
 as well. Village Engineer Pat Rank stated he would provide the contractor's information and
 residents could contact them for possible additional work on a private contract.
 - Dan Stokes asked how the special assessments are decided (calculation based on linear feet), inquired regarding a manhole by their residence and asked why the trees needed to be removed. Director Cockroft stated many trees are being removed as they are above the sewer main which is being replaced.
 - Arlene at 607 9th Avenue raised concerns about dust and stated she did not want a sidewalk and does not believe sidewalks are beneficial. She also asked how many bids were received and expressed concerns about the speed of traffic on 9th avenue following completion of the new road.
 - Kara Weber stated she believed additional planning sessions should have been held and
 residents should have provided input on the design of the project. She asked if the special
 assessment payback period could be extended.

- Susan Dial inquired about specific concerns related to her curb and sidewalk and also asked the process for paying the entire assessment up front.
- An additional resident who did not state their name asked where their tax dollars go and why
 special assessments are necessary if they pay taxes. Administrator Daily provided a brief
 summary of the services provided by the Village. Village Engineer Rank explained what costs of
 the project would be funded by general property taxes and which pieces were specially
 assessed.

Chair Kruse closed the public hearing at 8:00 PM
